Thursday, May 16, 2013

CALL TO ORDER

Chair Ann Ravel called the meeting to order at 10:00 a.m. at the Fair Political Practices Commission, 428 J Street, Sacramento, CA 95814. Chair Ravel and Commissioners Eric Casher, Gavin Hachiya Wasserman and Tricia Wynne were present and Commissioner Sean Eskovitz was not present.

WELCOME AND CHAIR'S REPORT

Chair Ann Ravel opened the meeting and mentioned that the filing period for the FPPC Executive Director nationwide search ended on May 15, 2013. Chair Ravel explained that the sub-committee will meet independently to select qualified applicants to interview. Thereafter, the most qualified candidates will meet with the Chair.

Tina Bass, Interim Executive Director addressed the Commission. Ms. Bass explained that the sub-committee received twenty-four applications. The sub-committee will meet to determine a selection process and will conduct interviews within the next two weeks.
