Re: Public Comment for FPPC Case No. 2020-00416 Charles Grace

Dear Commission Members:

Elected Officials represent the electorate, and who better knows the personal and political agendas and shenanigans of a small community than its citizen and the wisdom of their vote?

We respectfully request that you honor the wisdom of the majority of its citizens: residents, business owners, taxpayers and ratepayers of San Simeon. We believe that the San Simeon Community Services District and its agents: Charles Grace, Grace Environmental and staff have performed in an admirable, professional manner in the best interest of the community and have never created any harm to the community, its citizens or the public. They have, in our view, always given more to the District than their duties or contract required and have always been guided solely by the public interest of the citizen's and District.

They as a team, and individually, have guided our community through many protracted issues that preceded their engagement. These include many health and safety issues at our water production facility, ground water intrusion from both seawater intrusion and surface water contamination, unpermitted riprap at our community's wastewater treatment plant and the existence of extremely deferred maintenance as a result of the previous operators, etc. It should be noted that many of these have been encountered in times of emergencies, such as violations that were encountered upon their arrival (note, none since), emergency coverage when the previous vendor walked away, and drinking water quality issues during droughts, etc.

They have been instrumental in maintaining positive professional relationships with our regulatory agencies, California State Department Parks and Recreation and their facility at Hearst Castle, Hearst Corporation, and a vast majority of our citizens, etc.

Please note that at the time of this writing, a third Member of our District's Board has resigned as a result of the constant, disrespectful treatment and harassment perpetuated by the minority (small) of individuals. Who will perpetuate our Democracy and this form of governance if this is allowed to continue? Please respect and honor the decisions and judgements of our elected Board of Directors and the citizens who put them there.

Out of respect for your time we will end our request by asking that you adopt the stipulation that was appropriately submitted at your October 21 ,2021 meeting. No harm has been caused to our citizens, the public or our District by any actions of Charles Grace, Grace Environmental, its staff or the Board of Directors of the San Simeon Community Services District. Please respect the decisions of our Elected Officials and the judgements they have made while volunteering their time to improve the District for its citizens.
