

1 Amend 2 Cal. Code Regs. Section 18115.2 as follows:

2 **18115.2 Duties of Filing Officers and Filing Officials – ~~Electronically Filed~~ Electronic**
3 **Format Statements of Economic Interests**

4 (a) Pursuant to Section 81010(b), a filing officer shall review a statement of economic
5 interests submitted through the Commission's electronic filing system or an electronic filing
6 system approved by the Commission pursuant to Section 87500.2(c)(3), or filed pursuant to
7 subdivision (b) of Regulation 18757, to ensure the statement:

8 (1) Contains the filer's full name, formal official title or designated position, an email
9 address, and the residential or business street address of the filer. The filing officer shall ensure
10 that the filer's full name and the formal position title are complete and accurate to promote the
11 accuracy and consistency of electronic filing system databases and electronic recordkeeping.

12 (2) ~~Has been digitally signed and dated by the filer~~ Contains the filer's secure electronic
13 signature and date in compliance with Section 81004, unless the statement is an expanded
14 statement filed for an additional position under Regulation 18723.1.

15 (3) If filed through an electronic filing system, sets ~~Sets~~ forth the System Acceptance
16 Number ("SAN") assigned by the Commission to the approved electronic filing system verifying
17 the Commission's certification of the system under Regulation 18756.

18 (b) The filing officer shall promptly notify the filer if the review of ~~an electronically filed~~
19 a statement of economic interests required by subdivision (a) indicates that the statement is
20 incomplete or incorrect in any material respect.

21 (c) ~~An electronically filed statement of economic interests, filed through the~~
22 ~~Commission's electronic filing system or an approved electronic filing system, which displays the~~

1 ~~electronic filing system's SAN, is an original statement for purposes of the Act. A digital~~
2 ~~signature on a statement filed through the Commission's electronic filing system or an approved~~
3 ~~electronic filing system fulfills the requirement of Section 81004 that the statement be signed~~
4 ~~under the penalty of perjury.~~

5 (c) With respect to a statement of economic interests submitted with a secure electronic
6 signature pursuant to subdivision (b) of Regulation 18757, a filing official, the agency official
7 who receives statements and forwards those statements under Section 87500, shall forward an
8 electronic copy of the original statement, which itself is an original statement under subdivision
9 (a) of Regulation 18104, to the filing officer via email and make and retain an electronic copy of
10 the statement.

11 (d) With respect to ~~an electronically filed~~ a statement of economic interests filed through
12 the Commission's electronic filing system or an approved electronic filing system, a filing
13 official, the agency official who receives statements and forwards those statements under Section
14 87500, shall forward an electronic copy of the original statement, which itself is an original
15 statement under subdivision ~~(e)~~ (a) of Regulation 18104, to the filing officer through the
16 electronic filing system and make and retain an electronic copy of the statement. If the
17 Commission is the filing officer, an electronic statement filed through an approved electronic
18 filing system must be forwarded to the Commission by means of automated data exchange
19 between the approved electronic system and the Commission's electronic filing system.

20 (e) If the Commission assumes filing officer duties for an agency under Section
21 87500.4(b)(1), the agency shall provide the Commission with the name and contact information
22 for each individual with filing obligations as required by Section 87500.4(b)(2).
