4	(a) An officer knows or has reason to know that a person has a financial interest in the

7	(2) The person is a participant and reveals facts in a written or oral support or opposition
8	before the agency which make the person's financial interest apparent, or the officer has actual
9	knowledge of the financial interest.
10	(b) In determining whether facts revealed by a participant in written or oral support or
11	opposition before the agency have made the participant's financial interest apparent, all relevant
12	facts known by the official at the time of the decision must be considered including, but not
13	limited to the following:
14	(1) Whether a financial effect on a participant's stated economic interests can be
15	recognized as a realistic possibility and more than hypothetical or theoretical;
16	(2) The specificity with which the participant has described the proximity of the
17	participant's real property interests to real property that is a subject of the proceeding. Where the
18	participant's description expressly or reasonably implies a real property interest within 500 feet
19	of the subject real property and there is no clear and convincing evidence the proceeding will not
20	have any measurable impact on the participant's real property interest, a financial interest is
21	apparent;
22	(3) The specificity and extent of the participant's description of potential financial effects
23	on the participant's economic interests, including financial effects on:
24	(A) Development potential of real property;

9	(b) (c) An officer knows, or should have known, about a proceeding pending before the

14	(2) The officer has actual knowledge of the proceeding.

18	(2) The officer has actual knowledge of the contribution.
19	(e) As used in Section 84308(c), the phrase "make, participate in making, or in any way
20	attempt to use the officer's official position to influence the decision" has the same meaning as
21	specified in Regulation 18704.
22	(f) Return of Contributions. Where an officer would otherwise be disqualified under
23	Section 84308 from taking part in a proceeding before the officer at a public meeting of a
24	governing body or board, the officer may permissibly take part in the proceeding prior to
