I am requesting a motion to vacate judgement as noted on the notice I received September 23, 2023.

I am aware that a fine will be imposed if I do not respond and after reviewing the accusation documents, I noticed that there were concerns which I was not allowed to address, as I was informed the decision was made and not much I could do. I was made aware of your hearing back in June 2023, and it was postponed, reschedule, postponed and finally rescheduled. I was not able to make my presence (virtually) after rescheduling. I believe I am responding within the time you have asked given the 3-month delay by FPPC.

Initially when I was contacted with the accusation and documents mailed by Jenna Rinehart, Commission Counsel Enforcement Division, I sent an email acknowledging the accusation against me. I also requested information from Ms. Rinehart which I did not receive nor was it addressed. (See attached document 1: I am requesting copies of evidence of numerous checks written as sources of income. Please email them to me. Thank you, Jose Pech).

The accusation of not filling out a SEI form soon after I separated from my employer, however the most recent on was completed 03/11/2019 (see attached document 2, copy of SEI / California Form 700), two months prior to my separation from my employer. What is a 2-month difference between if nothing had changed.

I am requesting the dismissal of two of the three accusations including fines imposed against me.
