- means a bidder who has demonstrated the attribute of trustworthiness, as well as quality, fitness,
- capacity, and experience to satisfactorily perform the contract. "Responsive bid" means a bid that
- indicates compliance without material deviation from the requirements of the solicitation and the
- 18 <u>terms and conditions of the proposed contract.</u>
- 19 (B) A "labor contract" is a contract or agreement reached through collective bargaining
- or with a representative group regarding the salary, benefits, or terms and conditions under an

- 22 <u>entered under Public Contract Code Section 2500.</u>
- 23 (C) A "personal employment contract" is a contract for employment, including the terms

2	independent contractor is neither a labor agreement nor personal employment contract.
3	(b) A proceeding involving a license, permit or other entitlement for use is "pending
4	before" an agency:
5	(1) When the application has been filed, the proceeding has been commenced, or the issue
6	has otherwise been submitted to the jurisdiction of an agency for its determination or other
7	action;
8	(2) It is the type of proceeding where the officers of the agency are required by law to
9	make a decision, or the matter has been otherwise submitted to the officers of the agency for their
10	decision; and
11	(3) The decision of the officer or officers with respect to the proceeding will not be purely
12	ministerial.
13	(b) "Pending." A proceeding involving a license, permit, or other entitlement for use has
14	commenced and is considered pending only under the following circumstances:

17	(A) The decision is before the officer for the officer's consideration. If the officer is a
18	member of a governing body, this includes any item placed on the agenda for discussion or
