

1 Amend 2 Cal. Code Regs. Section 18438.8 as follows:

2 **§ 18438.8. Disclosure Under Government Code Section 84308.**

3 (a) ~~(1)~~ An officer who is required by ~~section~~ Section 84308(c) to disclose the receipt of a  
4 contribution shall disclose any disqualifying contribution the officer knows of or has reason to  
5 know of, either orally or in writing, on the public record at the beginning of a public meeting in  
6 a proceeding involving the license, permit, or other entitlement for use, if a meeting is held.

7 However, ~~in the circumstance where the~~ when an officer learns of ~~the~~ a disqualifying  
8 contribution during the public meeting, the officer shall make the disclosure on the public record  
9 prior to continuing to take part in the proceeding. If ~~there is~~ no public meeting is held, written  
10 disclosure shall be entered into the agency's official records. The officer, or an employee of the  
11 agency on behalf of the officer, shall disclose that the officer has received contributions from a  
12 party, participant, or agent of a party or participant, greater than ~~\$250~~ \$500 within the preceding  
13 12 months and the name(s) of the contributor(s).

14 (2) Confirmation of the return of any contribution pursuant to Section 84308(d)(1) shall  
15 be disclosed, either orally or in writing, on the public record at the beginning of a public  
16 meeting held within 60 days of return of the contribution or, if no public meeting is held within  
17 that time, written disclosure shall be entered into the agency's official records within 60 days of  
18 return of the contribution.

19 (b) Any party to a proceeding pending before an agency shall disclose on the record of  
20 the proceeding the names of any persons whose contributions are required to be aggregated, if  
21 the person has made a contribution greater than five hundred dollars (\$500) to any officer of the  
22 agency. The party shall disclose the amount of the contribution(s) made within the preceding 12  
23 months and the names of the contributors, including contributions made by an individual

1 required to be aggregated with the party ~~or the party's agent~~ under Section 82015.5. The party  
2 shall make the disclosure before the date that any decision is rendered by the agency. ÷

3 ~~(1) On the date the party files the application or other request initiating the proceeding.~~

4 ~~(2) For a contribution made at any stage during the proceeding, within 30 days of~~  
5 ~~making the contribution, or the date on which the party makes its first appearance before or~~  
6 ~~communication with the agency regarding the proceeding following the contribution, whichever~~  
7 ~~is earliest.~~

8 ~~(3)~~ (c) If an agent of a party makes an appearance before or communication with the  
9 agency subsequent to the party's disclosure, the party or agent must disclose the agent's identity  
10 on the date of the agent's first appearance before or communication with the agency following  
11 the party's disclosure.
