

1 Amend 2 Cal. Code Regs., Section 18723 to read:

2 **§ 18723. Dates for Filing Annual Statements of Economic Interests.**

3 (a) Each person who holds an office specified in Section 87200 shall file a Statement of  
4 Economic Interests each year in accordance with the schedule set forth in subsection (b)  
5 disclosing ~~his or her~~ the person's investments, interests in real property and income during the  
6 period since the closing date of ~~his or her~~ the person's last statement filed pursuant to Section  
7 87202 or 87203. The statement shall include any investments and interests in real property held  
8 at any time during the period covered by the statement, regardless of whether they are still held  
9 at the time of filing.

10 (b) The closing date for all persons required to file Statements of Economic Interests  
11 pursuant to Section 87203 shall be December 31. The filing deadlines for the Statements are as  
12 follows:

13 (1) For the Governor, Lieutenant Governor, Attorney General, Insurance Commissioner,  
14 Controller, Secretary of State, Treasurer, Superintendent of Public Instruction, members of the  
15 Legislature, members of the State Board of Equalization, judges and commissioners of courts of  
16 the judicial branch of government, members of the Public Utilities Commission, members of the  
17 State Energy Resources Conservation and Development Commission, members of the Fair  
18 Political Practices Commission, members of the California Coastal Commission, members of the  
19 High-Speed Rail Authority, members elected to the Board of Administration of the Public  
20 Employees' Retirement System, and members elected to the Board of Administration of the  
21 Teachers' Retirement Board, the filing deadline shall be March 1.

22 (2) For county supervisors, district attorneys, county counsels, county treasurers, county  
23 chief administrative officers, county planning commissioners, members of city councils, mayors,

1 city managers, city attorneys, city treasurers, city chief administrative officers and city planning  
2 commissioners, the filing deadline shall be April 1.

3 (3) For “other public officials who manage public investments” as that term is used in  
4 Section 87200, the filing deadline shall be April 1.

5 (c) If a person assumes an office specified in Section 87200 between October 1 and  
6 December 31 and files an assuming office Statement of Economic Interests pursuant to Section  
7 87202, that person need not file an annual Statement of Economic Interests pursuant to Section  
8 87203 until one year later than the date specified in subsection (b).

9 (d) If a person leaves an office specified in Section 87200 between January 1 and the  
10 filing deadline for ~~his or her~~ the person’s annual Statement of Economic Interests, the leaving  
11 office Statement of Economic Interests filed pursuant to Section 87204 may serve as that  
12 person's annual Statement. Prior to the filing deadline for the annual Statement the person shall  
13 notify the filing officer in writing that ~~he or she~~ the person intends to follow this procedure.

14 (e) If a person reports for military service, as defined in the Servicemember's Civil Relief  
15 Act, the deadline for the annual statement of economic interests is 30 days following ~~his or her~~  
16 the person’s return to office, provided the person or someone authorized to represent the person's  
17 interests, notifies the filing officer in writing prior to the applicable filing deadline that ~~he or she~~  
18 the person is subject to that federal statute and is unable to meet the applicable deadline and  
19 provides the filing officer verification of ~~his or her~~ the person’s military status.
