- E-Filer: A state committee that has received contributions of \$25,000 or more or made expenditures totaling \$25,000 or more since January 1, 2000.
- Form 460: All state committees must file paper reports with the Secretary of State and if an e-filer, an electronic copy. A copy must also be mailed to CalPERS at <a href="mailto:Board\_Election\_Coordinator@calpers.ca.gov">Board\_Election\_Coordinator@calpers.ca.gov</a>.
- Forms 496 and 497: All reports filed online only with the Secretary of State and e-mailed to CalPERS at <u>Board\_Election\_Coordinator@calpers.ca.gov</u>.

  Note: Form 497 is filed through September 28; Form 496 if filed through September 29. For the runoff election, Form 497 is filed through December 7; Form 496 is filed through December 8.
- Filing Deadlines: Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to any 24-hour independent expenditure reports (Form 496) or to 24-hour contribution reports (Form 497) that are due the weekend before the election. Such reports must be filed within 24 hours regardless of the day of the week. A \$10 per day late fine may be assessed on both the paper and electronic report resulting in a \$20 per day fine.
- Period Covered: The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- Contribution Limits: Contributions to CalPERS candidates are subject to contribution limits of \$4,100 per election. Committees that make contributions to CalPERS candidates are subject to contribution limits of \$6,800 per calendar year.
- Public Documents: All forms are public documents. Campaign manuals and instructional materials available at <a href="www.fppc.ca.gov">www.fppc.ca.gov</a>, click on the <a href="Campaign">Campaign</a> link.
- Voting Periods: Begin August 29, 2014 and November 7, 2014.
- Section 84200.9: Sets pre-election deadlines.
