Dear Landon Sudholt:

This letter responds to your request for advice on behalf of the County of Calaveras regarding the campaign provisions of the Political Reform Act (the “Act”).<sup>1</sup>

### QUESTION

May the committees involved in the County’s August 26, 2025, election combine the semi-annual statement with the first pre-election statement due July 17, 2025?

### CONCLUSION

In connection with the August 26, 2025, election, committees may use a filing schedule that combines the semi-annual campaign statement with the first pre-election statement. The combined statement will be due on July 17, 2025, covering the period January 1, 2025, through July 12, 2025.

### ANALYSIS

Committees are required to file two pre-election campaign statements during an election, disclosing contributions received and expenditures made in connection with that election. These statements are filed 40 days before the election and again 12 days before the election. (Section 84200.8.) Semi-annual statements are filed on January 31 and July 31, respectively. (Section 84200.)

The County of Calaveras is holding a special election on August 26, 2025. The first semi-annual report for 2025, covering the period January 1 through June 30, is due on July 31, 2025. The first pre-election statement filed in connection with this election would then cover the period of July

1 through July 12. It would be due on July 17, 2025, before the deadline for the semi-annual statement. The second pre-election statement is due on August 14, 2025, and covers the reporting period of July 13 through August 9.

There is a mechanism in the Act that permits combining statements when an overlapping reporting period occurs, or the filing of the semi-annual statement would be an additional, unnecessary filing to the two pre-election statements. (Section 84205.) Combining the first pre-election statement with the semi-annual statement would be appropriate for the County's August 26, 2025, election.

Accordingly, specified committees involved with the August 26, 2025 measure appearing on the ballot may combine the semi-annual statement with the first pre-election statement. The statement will cover the period of January 1 through July 12 and be due on July 17, 2025. A campaign statement filing schedule that outlines the due dates for filing statements is enclosed for your convenience.
